Active and Passive Appreciation on Marital Property

In North Carolina, divorce-related division of assets and debts falls under the North Carolina General Statute § 50-20, categorizing property into marital, separate, and divisible. Marital property includes assets acquired by spouses during the marriage until separation, while separate property is obtained either before marriage or individually during marriage. Divisible property covers post-separation asset appreciation. The law favors equal division of marital property unless proven otherwise. Changes in asset values, through active or passive appreciation, are considered in the division. Courts assess whether distribution should be equal or unequal based on these factors. For legal assistance in such cases, Jetton & Meredith's attorneys are available for guidance.



How to get your Mugshot Removed from the Internet

After having criminal charges dismissed and expunged, individuals often find their mugshots still online, hindering future prospects. Efforts to remove these images can be met with unresponsiveness or demands for payment from website owners. State agencies are supposed to instruct web businesses to delete such records for expunged cases, but compliance varies. Individuals can contact these websites with proof of expungement or dismissal, or seek legal assistance. If websites refuse removal, legal action is an option under specific statutes, but it requires hiring a lawyer and can be a lengthy and complex process.
