Our staff is continuing to grow! We are pleased to introduce you to Christine Carver, who will soon be sworn in and join our Family Law team as an attorney.

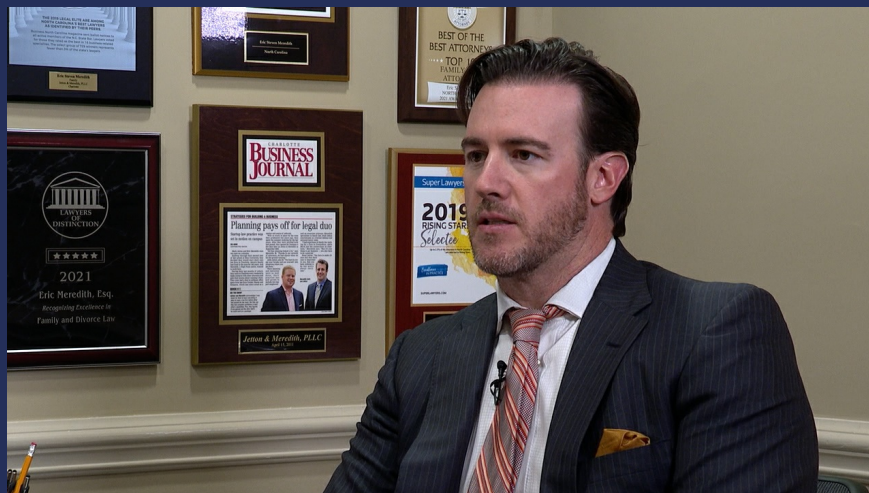

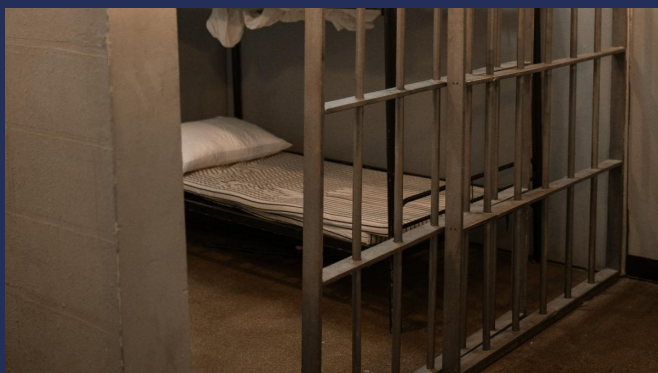

Diana Cojocari, the mother of missing Cornelius girl Madalina Cojocari, has been charged with drug possession while in jail, according to the Mecklenburg County Sheriff's Office. Cojocari and her husband, Christopher Palmiter, were arrested in December for failing to report Madalina's disappearance. According to the arrest warrant, on March 17, "a small clear plastic bag containing a white powder was found in her shirt pocket." The substance inside the bag was tested and returned positive for a "cocaine and fentanyl-based substance."
